By submitting this form, you consent that you fully understand the application and that you agree to fully abide by the agreement. Please return this form to Sumner County Tourism, P.O. Box 957, Gallatin, TN 37066. Applications must be received no later than February 10, 2023. (This deadline will be strictly enforced).

All spaces must be reserved in advance and approved by the County Sumner Irish Fest committee.

No food or beverages deemed inappropriate or illegal by the State of Tennessee may be sold. It is acknowledged by the parties to this application that Sumner County Tourism by and through its agents reserves the absolute right to ask any vendor to leave the event premises if in its sole discretion it deems the conduct of the vendor or any portion or component of the vendor's display as disruptive or otherwise unfit for the event. If a vendor is asked to leave the event premises, the vendor understands and agrees that fees paid to the event are forfeited.

Tennessee State sales tax will be the sole responsibility of the vendor. The vendor understands that it is their responsibility to provide their booth, tent, trailer, and their own display equipment including table coverings, tables, chairs, adequate signage, sandbags, etc. The vendor is also responsible for their own water and electricity.

The vendor is only allowed to sell food and beverage items and must submit a complete menu to include prices of items to be sold at this event. It is understood that spaces will not be allocated until menu information is received.

Vendors will not be allowed to sell alcoholic beverages. Any violation of this policy will result in immediate termination of this contract.

The vendor agrees to submit a certificate of insurance with a minimum of \$1,000,000 insurance liability coverage and present an insurance certificate listing Sumner County Tourism as an additional insured for one million (\$1,000,000.00). The vendor also agrees to indemnify and hold harmless: Sumner County Tourism, Sumner County Government, Bledsoe Fort Historical Park, Bledsoe Lick Historical Association, and staff and boards of these organizations against any claim or action for any cause. Vendors will not be allowed to participate in the event if the certificate of insurance is not received by February 10, 2023.

The County Sumner Irish Fest reserves the right to cancel any contract upon receipt of notice from any fair, festival, or other event that the exhibitor/concessionaire/vendor has been suspended, expelled from, or otherwise penalized for violation of contract terms or rules of the venue.

Vendors agree that event organizers and Sumner County Tourism are not responsible for any damaged, lost, or stolen items.

The vendor understands that the County Sumner Irish Fest name and logo are restricted trademarks. As such, any use of these is strictly prohibited without written consent from Sumner County Tourism.

All vendors can start setting up on Saturday, March 11, 2023, (rain date, Sunday, March 12, 2023), at 8:00 am and must be fully set up by 10:00 am. There will be no vehicles allowed in the area after 9:30 am CST. All vendors are required to stay the entire event. NO EXCEPTIONS. Service vehicles will be allowed to park in designated areas only.

Rental space must be vacated and cleaned of all trash and debris by 5:00 pm CST on March 11, 2023, (rain date, Sunday, March 12, 2023). Please make sure you leave your space as clean as when you arrived.

Vendor understands they are responsible for their employees and will ensure that their actions reflect favorably on The County Sumner Irish Fest sponsors and organizers.
